



ACADEMIC COOPERATION AGREEMENT
between



KYRGYZSTAN -TURKEY MANAS UNIVERSITY
(Bishkek, Kyrgyzstan)
and **XINJIANG UNIVERSITY of FINANCE and ECONOMICS**
(Urumqi, China)

Kyrgyzstan-Turkey Manas University and Xinjiang University of Finance and Economics, hereby agree to foster academic exchange and cooperation between the two institutions.

SCOPE OF COOPERATION

Subject to mutual consent, the areas of cooperation will include any program offered by either institution as felt desirable and feasible on either side and that contributes to fostering and development of the cooperative relationship between the two universities.

Cooperation may be carried out through such activities as:

- Exchange of faculty and/or staff;
- Exchange of graduate and/or undergraduate students;
- Mutual support in supplying education materials and teachers, specialists in Chinese, Kyrgyz, Turkish and Russian Languages
- Support providing of Curriculum Development of Chinese language;
- Joint conferences and academic programs;
- Joint research activities and publications;
- Providing of Kyrgyz, Turkish and Russian Class in Kyrgyzstan-Turkey Manas University for students from China
- Exchange of scientific materials, publications, and information;
- Exchange of cultural activities;
- Providing of students summer internships'

These activities are to be carried out after mutual consultation between the two institutions or the divisions concerned thereof. Normally each institution will sign a letter of agreement setting out the responsibilities of each institution for the agreed activity and such other matters as the institutions agree are necessary for the efficient achievement of the activity.

ADMINISTRATIVE RESPONSIBILITY

The Office of International Affairs at Kyrgyzstan-Turkey Manas University and Xinjiang University of Finance and Economics shall serve as coordinators of this agreement at their respective institutions. Notification of any change in liaison officers may be made by letter.

AMENDMENTS, RENEWAL, AND TERMINATION

This Academic Cooperation Agreement may be modified through the mutual discussion and consent of the two universities, and shall remain in effect from the date of signature for an initial period of five years. Thereafter it shall be automatically renewed each year; however, after the initial period either university may terminate the agreement by giving six months written notice of such intent.

IN WITNESS WHEREOF the parties hereto have executed the Academic Cooperation Agreement as of the date September 16, 2013.
